4. First-aid measures

Inhalation

Move to fresh air. Call a physician if symptoms develop or persist.

Skin contact

Rinse skin with water/shower. For minor skin contact, avoid spreading material on unaffected skin. Wash clothing separately before reuse. Get medical attention if irritation develops and persists.

General information

Remove from exposure. Remove contaminated clothing. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

5. Fire-fighting measures

Suitable extinguishing media

Water fog. Carbon dioxide (CO₂). Foam. Dry chemical powder.

Unsuitable extinguishing media

Do not use water jet as an extinguisher, as this will spread the fire.

By heating and fire, harmful vapors/gases may be formed.

Special protective equipment and precautions for firefighters

Wear suitable protective equipment.

6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

Keep unnecessary personnel away. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Avoid inhalation of vapors. Ensure adequate ventilation. Wear appropriate personal protective equipment. For personal protection, see section 8 of the SDS. ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area).

Methods and materials for containment and cleaning up

Remove sources of ignition. Absorb spillage with suitable absorbent material. Keep combustibles (wood, paper, oil, etc.) away from spilled material. Clean surface thoroughly to remove residual contamination. For waste disposal, see section 13 of the SDS.

Environmental precautions

Avoid discharge into drains, water courses or onto the ground.

7. Handling and storage

Precautions for safe handling

As a general rule, when handling USP Reference Standards, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.

Store in tight container as defined in the USP-NF. This material should be handled and stored per label instructions to ensure product integrity.
