4. First-aid measures

Inhalation	Move to fresh air. Call a physician if symptoms develop or persist.
Skin contact	Wash off with soap and water. Get medical attention if irritation develops and persists.
Eye contact	Rinse with water. Get medical attention if irritation develops and persists.
Ingestion	Call a physician or poison control center immediately. Rinse mouth. Do not induce vomiting without advice from poison control center. Do not use mouth-to-mouth method if substance is ingested. If vomiting occurs, keep head low so that stomach content doesn't get into the lungs. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device.
Most important symptoms/effects, acute and delayed	Potent pharmacologically active material. Occupational exposure to small amounts may cause physiological effects.
Indication of immediate medical attention and special treatment needed	Provide general supportive measures and treat symptomatically. Treatment of clonidine overdose may include the following: Administer activated charcoal as a slurry. Induced vomiting is NOT recommended. Perform gastric lavage unless contraindicated. This is most effective within one hour of ingestion. Protect airway and control seizures before initiating. Monitor ECG, pulse oximetry, and vital signs. For respiratory depression, hypotension, and coma, naloxone administered intravenously may be effective. For hypotension, infuse isotonic fluid. If persistent, administer dopamine or norepinephrine. For severe hypertension, use continuous IV infusion of nitroprusside. For bradycardia, administer atropine intravenously and consider pacemaker insertion if severe. Treat seizures with a benzodiazepine IV or barbiturates if needed.
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

For personal protection, see section 8 of the SDS.
Methods and materials for containment and cleaning up	Avoid the generation of dusts during clean-up. Sweep up or vacuum up spillage and collect in suitable container for disposal. Clean surface thoroughly to remove residual contamination. For waste disposal, see section 13 of the SDS.
Environmental precautions	Avoid discharge into drains, water courses or onto the ground.

7. Handling and storage

Precautions for safe handling	As a general rule, when handling USP Reference Standards, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.
Conditions for safe storage, including any incompatibilities	Store in tight container as defined in the USP-NF. This material should be handled and stored per label instructions to ensure product integrity.
