4. First-aid measures

Inhalation	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Call a physician if symptoms develop or persist.

Indication of immediate medical attention and special treatment needed	Treat symptomatically. Treatment of tetracycline overdose may include the following: Immediately dilute with water or milk. Gastrointestinal decontamination is generally not required due to low order toxicity. Administer activated charcoal as a slurry. For gastrointestinal irritation, administer antacids. For mild/moderate allergic reaction, administer antihistamines with or without inhaled beta agonists, corticosteroids, or epinephrine. For severe allergic reactions, treat with aggressive airway management, antihistamines, epinephrine, corticosteroids, ECG monitoring, and IV fluids.
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

7. Handling and storage

Precautions for safe handling	As a general rule, when handling USP materials, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.

Tetracyclines: Use of tetracyclines during the last half of pregnancy may cause permanent discoloration of the teeth, incomplete development or lack of enamel, and inhibition of skeletal growth in the fetus. Tetracyclines administered early in pregnancy have been found to cause harm to the embryo, including congenital cataracts. In addition, fatty infiltration of the liver, leading to damage or failure, may occur in pregnant women.
