For torsades de pointes in stable patients, treat with magnesium, isoproterenol, and/or atrial overdrive pacing. Monitor electrolyte balance. AVOID class Ia (quinidine, disopyramide, procainamide, aprindine), class Ic (flecainide, ecainide, propafenone) and most class III antidysrhythmics (N-acetylprocainamide, sotalol). Monitor cardiac function. Enhanced elimination with hemodialysis, exchange transfusion, AV hemofiltration, and forced diuresis has not been shown to increase clearance substantially. (Meditext) (PDR)
General information	Remove from exposure. Remove contaminated clothing.
