4. First-aid measures

Inhalation	Move to fresh air. Call a physician if symptoms develop or persist.

Indication of immediate medical attention and special treatment needed	Provide general supportive measures and treat symptomatically. Treatment of antiviral protease inhibitor overdose may include the following: Administer activated charcoal as a slurry. Consider gastric lavage if it can be performed soon after ingestion, unless contraindicated. Protect airway and control seizures first. For seizures, administer a benzodiazepine intravenously. Consider phenobarbital or propofol if seizures recur. Monitor for hypotension, dysrhythmias, respiratory depression, need for endotracheal intubation, hypoglycemia, electrolyte disturbances, and hypoxia.
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

6. Accidental release measures

Personal precautions, protective equipment and emergency procedures	Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Keep unnecessary personnel away. Avoid inhalation of dust from the spilled material. Wear appropriate personal protective equipment. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ensure adequate ventilation. For personal protection, see section 8 of the SDS.
Methods and materials for containment and cleaning up	Avoid the generation of dusts during clean-up. Sweep up or vacuum up spillage and collect in suitable container for disposal. Clean surface thoroughly to remove residual contamination. For waste disposal, see section 13 of the SDS.
Environmental precautions	Avoid discharge into drains, water courses or onto the ground.

7. Handling and storage

Precautions for safe handling

As a general rule, when handling USP Reference Standards, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Avoid significant deposits of material, especially on horizontal surfaces, which may become airborne and form combustible dust clouds and may contribute to secondary explosions. Combustible dust clouds may be created where operations produce fine material (dust). Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.
