4. First-aid measures

One study comparing mothers exposed to proton pump inhibitors and those exposed to non-teratogens during pregnancy found no difference between the groups in the incidence of major malformations in their offspring, while another study of 549 infants exposed in utero to proton pump inhibitors found no significant correlation between first trimester exposure and birth defects.
