4. First-aid measures

Inhalation	Move to fresh air. Call a physician if symptoms develop or persist.
Skin contact	Rinse skin with water/shower. Get medical attention if irritation develops and persists.
Eye contact	Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Call a physician or poison control center immediately.
Ingestion	Rinse mouth. If vomiting occurs, keep head low so that stomach content doesn't get into the lungs. Get medical advice/attention if you feel unwell.
Most important symptoms/effects, acute and delayed	Pharmaceutical related compound of unknown potency. It is not known if occupational exposure may cause physiological effects.
Indication of immediate medical attention and special treatment needed	Treat symptomatically. Treatment may include the following: Do not induce vomiting. To decrease absorption, perform gastric lavage and administer activated charcoal as a slurry. Monitor cardiac and central nervous system function; establish and monitor airway; monitor vital signs. For hypotension, infuse isotonic fluid. If hypotension persists, administer dopamine or norepinephrine. For seizures, administer an intravenous benzodiazepine. If seizures recur, consider phenobarbital or propofol. Monitor for hypotension, dysrhythmias, respiratory depression, and need for endotracheal intubation. Evaluate for hypoglycemia, electrolyte disturbances, and hypoxia. For serotonin syndrome, administer cyproheptadine orally. Due to the large volume distribution of paroxetine, forced diuresis, hemodialysis, hemoperfusion, or exchange transfusions are not likely to be of benefit.
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

Methods and materials for containment and cleaning up	Avoid the generation of dusts during clean-up. Sweep up or vacuum up spillage and collect in suitable container for disposal. Clean surface thoroughly to remove residual contamination. For waste disposal, see section 13 of the SDS.
Environmental precautions	Avoid discharge into drains, water courses or onto the ground.

7. Handling and storage

Precautions for safe handling	As a general rule, when handling USP Reference Standards, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.
Conditions for safe storage, including any incompatibilities	Store in tight container as defined in the USP-NF. This material should be handled and stored per label instructions to ensure product integrity.

Therapeutic use of SSRIs late in pregnancy may be associated with a transient syndrome of central nervous system, motor, respiratory, and gastrointestinal effects in the newborn. Epidemiological studies have shown an association between therapeutic use of paroxetine in the first trimester and an increased risk of congenital malformations, particularly cardiac defects, in the newborn. It is not known if this material causes the same effects.
