7. Handling and storage

Precautions for safe handling	As a general rule, when handling USP Reference Standards, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.

Reproductive toxicity Knowledge about health hazard is incomplete.
Therapeutic use of paroxetine (a related compound) in the first trimester has been associated with increased risk of congenital and cardiovascular malformations in the newborn. Some newborns whose mothers took paroxetine in the third trimester have developed complications requiring prolonged hospitalization, respiratory support, and tube feeding. These may result from toxic effects of the drug, withdrawal effects, or serotonin syndrome. It is not known if this material causes the same effects.

Specific target organ toxicity - single exposure Knowledge about health hazard is incomplete.
