4. First-aid measures

Inhalation	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Call a physician if symptoms develop or persist.

Indication of immediate medical attention and special treatment needed	Provide general supportive measures and treat symptomatically. Treatment of statin overdose may include the following: Administer activated charcoal as an aqueous slurry. For rhabdomyolysis, administer 0.9% saline to maintain urine output of 2 - 3 milliliters/kg/hour. Monitor fluid balance, serum electrolytes, CPK, liver enzymes, and renal function. Administer diuretics if needed to maintain urine output. Urinary alkalization is not recommended. Hemodialysis is not expected to enhance clearance.
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

Results of animal studies indicate that many statins are associated with adverse fetal outcomes at maternally toxic doses. It is not known if this compound causes the same effects.
