4. First-aid measures

Inhalation	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Call a physician if symptoms develop or persist.

7. Handling and storage

Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.

Appropriate engineering controls

For laboratory operations, use local exhaust ventilation or a ventilated enclosure for high energy operations such as particle sizing.
