4. First-aid measures

Inhalation	Move to fresh air. Call a physician if symptoms develop or persist.
Skin contact	Wash off with soap and water. Get medical attention if irritation develops and persists.
Eye contact	Rinse with water. Get medical attention if irritation develops and persists.
Ingestion	Call a physician or poison control center immediately. Rinse mouth. Do not induce vomiting without advice from poison control center. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device.
Most important symptoms/effects, acute and delayed	Cardiovascular effects. Neuromuscular disturbances. Potent pharmacologically active material. Occupational exposure to small amounts may cause physiological effects.
Indication of immediate medical attention and special treatment needed	Treat symptomatically. Treatment of cholinergic agonist overdose may include the following: Administer activated charcoal as a slurry unless contraindicated. This is most effective when administered within one hour of ingestion. For muscarinic symptoms, administer atropine sulfate intravenously. For bronchospasm, administer epinephrine. Inhaled beta-agonist bronchodilators may reverse bronchoconstriction. Systemic corticosteroids may be needed. For lung injury, maintain ventilation and oxygenation by employing early use of PEEP and mechanical ventilation if needed. Monitor arterial blood gas frequently. For seizures, administer a benzodiazepine intravenously, followed by phenobarbital or propofol if the seizures recur. Monitor for hypotension, dysrhythmias, respiratory depression, and need for endotracheal intubation. Evaluate for hypoglycemia, electrolyte disturbances, hypoxia.
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

Methods and materials for containment and cleaning up	Avoid the generation of dusts during clean-up. Sweep up or vacuum up spillage and collect in suitable container for disposal. Clean surface thoroughly to remove residual contamination. For waste disposal, see section 13 of the SDS.

7. Handling and storage

Precautions for safe handling	As a general rule, when handling USP Reference Standards, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.
