4. First-aid measures

Inhalation	Move to fresh air. Oxygen or artificial respiration if needed. Do not use mouth-to-mouth method if victim inhaled the substance. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Call a physician or poison control center immediately.
Skin contact	Immediately flush skin with plenty of water. Get medical attention if irritation develops and persists.
Eye contact	Immediately flush eyes with plenty of water for at least 15 minutes. Get medical attention if irritation develops and persists.

For severe cardiovascular or bronchoconstrictor responses, administer epinephrine. It is not known if this material is dialyable. (PDR) (Drugdex)
General information	Remove from exposure. Remove contaminated clothing.
