An industrial hygiene survey involving air monitoring may be used to determine the effectiveness of engineering controls. Effectiveness of engineering controls intended for use with highly potent materials should be assessed by use of nontoxic surrogate materials.

Hand protection	Chemically compatible gloves. For handling solutions, ensure that the glove material is protective against the solvent being used.
