4. First-aid measures

Inhalation	Remove person to fresh air and keep at rest in a position comfortable for breathing. Oxygen or artificial respiration if needed. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Do not use mouth-to-mouth method if the substance is inhaled. Call a physician or poison control center immediately.
Skin contact	Wash off with soap and water. Get medical attention if irritation develops and persists.
Eye contact	Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Call a physician or poison control center immediately.
Ingestion	Rinse mouth. Do not use mouth-to-mouth method if substance is ingested. Get medical advice/attention if you feel unwell.

Indication of immediate medical attention and special treatment needed	Provide general supportive measures and treat symptomatically.
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

7. Handling and storage

Precautions for safe handling	As a general rule, when handling USP materials, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.
