4. First-aid measures

Indication of immediate medical attention and special treatment needed	Provide general supportive measures and treat symptomatically. Treatment for overdose of polyethylene glycol may include the following: Monitor acid-base balance, renal function, pulmonary function, serum calcium, osmolality, and pulse oximetry. For acidosis, administer sodium bicarbonate intravenously. For acute lung injury, maintain ventilation and oxygenation. Early use of PEEP and mechanical ventilation may be needed. Onset of acute lung injury may be delayed 24 to 72 hours after exposure. Hemodialysis may be beneficial in severe acid-base imbalances or in renal failure.
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

Methods and materials for containment and cleaning up	For waste disposal, see section 13 of the SDS. Avoid the generation of dusts during clean-up. Sweep up or vacuum up spillage and collect in suitable container for disposal. Clean surface thoroughly to remove residual contamination.
