Indication of immediate medical attention and special treatment needed	Overdose treatment for flutamide, a related compound, should be symptomatic and supportive and may include the following: Administer activated charcoal as a slurry. Consider gastric lavage if it can be performed soon after ingestion, unless contraindicated. Control seizures prior to initiation and protect airway. In agitated patients with hypertension and tachycardia, sedate with benzodiazepines. For severe hypertension, administer nitroprusside, labetalol, nitroglycerin, or phentolamine. For methemoglobinemia, slowly administer methylene blue intravenously. Monitor liver and kidney function tests and ECG. Hemodialysis is not likely to be effective in removing flutamide. [Meditext]
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Precautions for safe handling	As a general rule, when handling USP Reference Standards, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly.

An industrial hygiene survey involving air monitoring may be used to determine the effectiveness of engineering controls.
