4. First-aid measures

Inhalation	Move to fresh air. Call a physician if symptoms develop or persist.
Skin contact	Rinse skin with water/shower. Get medical attention if irritation develops and persists.

Ingestion	Rinse mouth. Do not induce vomiting without advice from poison control center. If vomiting occurs, keep head low so that stomach content doesn't get into the lungs.

Indication of immediate medical attention and special treatment needed	Provide general supportive measures and treat symptomatically. Treatment of hydantoin anticonvulsant overdose may include the following: Administer activated charcoal as a slurry. Repeat oral charcoal doses may enhance total body clearance and elimination. Perform gastric lavage soon after ingestions (within one hour). Protect airway by placement in Trendelenburg and left lateral decubitus position or by endotracheal intubation. Control any seizures first. Hemodialysis and hemoperfusion are of little benefit. Forced diuresis, peritoneal dialysis, exchange transfusions, and plasmapheresis are ineffective.
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

7. Handling and storage

Precautions for safe handling	As a general rule, when handling USP materials, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.
