4. First-aid measures

Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.

Reproductive toxicity	Knowledge about health hazard is incomplete. Maternal glucose and maternal insulin antibodies can cross the placenta and may cause excess insulin levels in the fetus. This may lead to abnormally large newborns that may require early induced or cesarean delivery. Pregnant rats and rabbits given parenteral doses of insulin lispro up to 4 and 0.3 times, respectively, the average human dose showed no evidence of impaired fertility or fetal harm. Injection of two units of insulin into chicken egg yolk sacs during incubation led to skeletal defects in the chicks.
