4. First-aid measures

Inhalation	Move to fresh air. Call a physician if symptoms develop or persist.

Indication of immediate medical attention and special treatment needed	Treat symptomatically. Treatment for overdose of topoisomerase I inhibitors may include the following: For diarrhea, monitor fluid and electrolyte status and replace volume and electrolytes as needed. For early diarrhea with cholinergic symptoms, administer atropine. Treat late diarrhea with loperamide. For severe neutropenia, administer filgrastim subcutaneously. For thrombocytopenia or bleeding, administer transfusions. If infection occurs, culture and treat with appropriate antimicrobial agents. Monitor respiratory function. Corticosteroid therapy has been used with equivocal results for pneumonitis.
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

7. Handling and storage
