4. First-aid measures

Inhalation	Move to fresh air. Call a physician if symptoms develop or persist.
Skin contact	Wash off with soap and water. Get medical attention if irritation develops and persists.
Eye contact	Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical attention if irritation develops and persists.

Indication of immediate medical attention and special treatment needed	Treat symptomatically. Treatment of hyperkalemia resulting from overdose of potassium supplements may include: Discontinuation of potassium-containing blood products, food, and medications, as well as ACE inhibitors, beta-blockers, NSAIDs, heparin, cyclosporin, and potassium-sparing diuretics. Administration of 10% dextrose containing 10-20 units of insulin per liter. Correction of acidosis with IV sodium bicarbonate. Administration of a calcium salt to antagonize cardiotoxic effects. Removal of excess potassium from the body with exchange resins. Reduction of blood potassium levels by hemodialysis or peritoneal dialysis. Use of saline and loop diuretics to maintain high-urine output.
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

7. Handling and storage
