For severe allergic reactions, treat with oxygen, aggressive airway management, antihistamines, epinephrine, corticosteroids, ECG monitoring, and intravenous fluids. For acute renal failure, maintain adequate hydration to preserve renal hemodynamics. This material may be removed by hemodialysis.
General information	Remove from exposure. Remove contaminated clothing. 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures	Keep unnecessary personnel away. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ensure adequate ventilation. Wear appropriate personal protective equipment. Avoid inhalation of dust from the spilled material. For personal protection, see section 8 of the SDS. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration.

7. Handling and storage

Precautions for safe handling	As a general rule, when handling USP Reference Standards, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Avoid significant deposits of material, especially on horizontal surfaces, which may become airborne and form combustible dust clouds and may contribute to secondary explosions. Combustible dust clouds may be created where operations produce fine material (dust). Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.
Conditions for safe storage, including any incompatibilities	Store in tight container as defined in the USP-NF. This material should be handled and stored per label instructions to ensure product integrity.
