4. First-aid measures

Inhalation	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Call a physician if symptoms develop or persist.

Indication of immediate medical attention and special treatment needed	Treatment of SNRI (Serotonin and norepinephrine reuptake inhibitor) overdose should be symptomatic and supportive and may include the following: Gastrointestinal decontamination with activated charcoal is recommended. Maintenance of airway, breathing, circulatory status of the patient, in addition to ECG monitoring is warranted. Clinical assessment for signs that may indicate impending seizure activity or serotonin toxicity is important. Active measures should be taken to control muscular activity, lower temperature, and preserve renal function. Cyproheptadine may reverse serotonin toxicity.
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

Precautions for safe handling	As a general rule, when handling USP Reference Standards, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. An industrial hygiene survey involving air monitoring may be used to determine the effectiveness of engineering controls. Effectiveness of engineering controls intended for use with highly potent materials should be assessed by use of nontoxic surrogate materials. Local exhaust ventilation such as a laboratory fume hood or other vented enclosure is recommended, particularly for grinding, crushing, weighing, or other dust-generating procedures.
