4. First-aid measures

Inhalation	Move to fresh air. Call a physician if symptoms develop or persist.

Most important symptoms/effects, acute and delayed	Pharmacologically active material. Occupational exposure may cause physiological effects.
Indication of immediate medical attention and special treatment needed	Provide general supportive measures and treat symptomatically. Secure and maintain a patent airway and administer oxygen; in some patients, endotracheal intubation may be required. Induced vomiting is contraindicated after oral overdose due to rapid development of seizures. Administer charcoal as a slurry. For circulatory depression - Administer intravenous fluids and a vasopressor (such as ephedrine). For seizures, administer oxygen immediately. If seizures do not respond to respiratory support, administer a benzodiazepine such as diazepam (in 2.5 mg increments) or an ultra short-acting barbiturate such as thiopental or thiamylal (in 50 to 100 mg increments) intravenously every 2 to 3 minutes. The fact that these agents, especially the barbiturates, may cause circulatory depression when administered intravenously must be kept in mind. A neuromuscular blocking agent may also be used to decrease the muscular manifestations of persistent convulsions if positive pressure ventilation can be immediately provided. Hypoxia, hypercapnea, and acidosis can develop quickly following the onset of seizures. For methemoglobinemia - If methemoglobinemia does not respond to administration of oxygen, administer methylene blue (intravenously, 1 to 2 mg per kg of body weight as a 1% solution, over a 5-minute period). Continuously monitor blood pressure, heart rate, and neurologic and respiratory status.
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.
