4. First-aid measures

Inhalation	Move to fresh air. Call a physician if symptoms develop or persist.
Skin contact	Rinse skin with water/shower. Get medical attention if irritation develops and persists.

Indication of immediate medical attention and special treatment needed	Treat symptomatically. Overdose treatment should be supportive and may include the following: If a skin reaction occurs, diethyltoluamide should be removed by washing area with soap and water. Topical steroids or oral antihistamines may be indicated for severe skin reactions. If a small amount of diethyltoluamide was ingested and patient is fully alert, administer water orally. For large ingestions within a few hours, gastrointestinal decontamination should be considered. Protect airway from aspiration. Do not induce vomiting. Consider orotracheal or nasotracheal intubation for airway control in the patient who is unconscious, has severe pulmonary edema, or is in respiratory arrest. Positive pressure ventilation techniques with a bag valve mask may be beneficial. If convulsive activity develops, diazepam or other anticonvulsants may be required.
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.
