4. First-aid measures

Inhalation	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Oxygen or artificial respiration if needed. Do not use mouth-to-mouth method if the substance is inhaled. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Call a physician or poison control center immediately.
Skin contact	Rinse skin with water/shower. Get medical attention if irritation develops and persists.

General information	Remove from exposure. Remove contaminated clothing. 7. Handling and storage

Precautions for safe handling	As a general rule, when handling USP Reference Standards, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.

Appropriate engineering controls

No open handling. For laboratory operations, use approved ventilation or containment system (biological safety cabinet, ventilated balance enclosure, glovebox). Base the choice of skin protection on the job activity, potential for skin contact and solvents and reagents in use. Do not wear protective garments in common areas (e.g., cafeterias) or out-of-doors.

Respiratory protection

Use a powered air-purifying respirator (PAPR) with HEPA filters, disposable outerware and head cover for spill cleanup. Choose respiratory protection appropriate to the task and the level of existing engineering controls.

Thermal hazards

Wear appropriate thermal protective clothing, when necessary.

General hygiene considerations

Handle in accordance with good industrial hygiene and safety practice. Pharmacological effects may be seen with occupational exposure.
