4. First-aid measures

Inhalation	Move to fresh air. Call a physician if symptoms develop or persist.
Skin contact	Remove contaminated clothing immediately and wash skin with soap and water. In case of eczema or other skin disorders: Seek medical attention and take along these instructions.

Most important symptoms/effects, acute and delayed	Potent pharmacologically active material. Occupational exposure to small amounts may cause physiological effects.
Indication of immediate medical attention and special treatment needed	Provide general supportive measures and treat symptomatically. Treatment of aminoglycoside overdose may include: Administer activated charcoal as a slurry. For mild/moderate allergic reactions, administer antihistamines with or without inhaled beta agonists, corticosteroids or epinephrine; for severe reactions add aggressive airway management, oxygen, ECG monitoring, and intravenous fluids. Maintain urine output with IV fluids in patients with normal renal function. Consider dialysis in patients with renal failure. Complexation with intravenous ticarcillin may be effective.
General information	Remove from exposure. Remove contaminated clothing. For treatment advice, seek guidance from an occupational health physician or other licensed health-care provider familiar with workplace chemical exposures. In the United States, the national poison control center phone number is 1-800-222-1222. If person is not breathing, give artificial respiration. If breathing is difficult, give oxygen if available. Persons developing serious hypersensitivity (anaphylactic) reactions must receive immediate medical attention.

7. Handling and storage

Precautions for safe handling	As a general rule, when handling USP Reference Standards, avoid all contact and inhalation of dust, mists, and/or vapors associated with the material. Clean equipment and work surfaces with suitable detergent or solvent after use. After removing gloves, wash hands and other exposed skin thoroughly. Select and use containment devices and personal protective equipment based on a risk assessment of material potency and exposure potential.
